General update and/or information on AB 109 Realignment activities (Fiscal Impact: None) -

Chairperson Kuge – Stated that in FY 13/14, Kern County received 2.78% of \$998 million compared to 3.06% in the first year, indicating a decrease in share. There is no statewide permanent formula at this time. Beginning in FY 14/15, CSAC will decide a permanent formula for any future funding. Their current estimate indicates the statewide amount will decrease from \$998 million to \$934.1 million, making a higher percentage crucial to Kern County. If the percentage remains the same, Kern County would lose \$1.8 million. It will be very important for Kern County to have a strong voice to show progress. Kern County received 10.34% of the growth money which will be discussed later in the meeting.
