## Proposed Allocation Formula for Prison Realignment Growth Revenues to Counties Discuss the April 10, 2013 California State Association of Counties (CSAC) announcement for a

proposed policy for allocating supplemental prison realignment (AB 109) revenues to counties. Counties have until noon on Wednesday, April 17, 2013 to comment before CSAC votes to recommend this proposed policy to the California Department of Finance for inclusion in the State Budget (Fiscal Impact: None) –

John Nilon, County Administrative Officer – Presented a proposed emergency agenda item for the Board of Supervisors meeting the following day that adopts a position in opposition to the CSAC's proposed allocation of supplemental prison realignment (AB 109) revenues to counties. He indicated that the proposed formula automatically assigns 50% of the revenues to individual counties based on the base allocation formula. On November 13, 2012, the Board of Supervisors opposed the base funding formula methodology. Since the 50% minimum is going to counties based on a flawed

formula, Kern County is not accepting of the formula as it is proposed. If Kern County does not speak up now, then it shows Kern County is in agreement with the formula methodology, which it is not. Even with the supplemental/growth funds, Kern County will only receive \$7,718 per offender compared with other counties, such as Marin, who will receive up to \$67,985 per offender.

Staff recommendation for a proposed formula is to oppose the methodology, allow CAO to send CCP comments to CSAC and DOF, and establish an open dialogue to change the methodology. Nilon indicated that staff would recommend a flip in the proposed percentages of the "county minimum" to be 25% and the "estimate vs. actual" be 50%, and keep the other smaller percentages the same.
