 - i. Prospective Youth stay local
 - ii. DJJ closes via attrition Existing Youth stay at DJJ
 - d. Age of Jurisdiction
 - i. 21 Normal Cases
 - ii. 23 WIC 707(b) Offenses
 - iii. 25 WIC 707(b) with 7+ year aggregate term
 - e. Creates OYCR (Office of Youth and Community Restoration)
 - i. Under HHS Agency at State
 - ii. Shifts Juvenile grants from BSCC to OYCR by 1/1/25
 - iii. Receives and reviews County plans
 - iv. Creates Ombudsman
 - f. Funding Formula
 - i. DJJ population 30%, WIC 707(b) offenses 50%, county population of 10-17 20%
 - ii. Rolls out over 3 years
