





### KERN COUNTY SECURE TRACK DEMOGRAPHICS











### KERN COUNTY SECURE TRACK DEMOGRAPHICS

Title: Request for Amendment No. 1 to Agreement #081-2021 with Garden

**Pathways** 

**Background:** On February 23, 2021, on behalf of the JJCC, the Probation Department

entered into an Agreement with Garden Pathways, Inc., to provide comprehensive mentoring and case management services to at-promise youth and youth involved in the juvenile justice system from March 1, 2021, through December 31, 2023, in an amount not to exceed \$1,363,374.15. Under Amendment No. 1 to Agreement 081-2021, Garden Pathways Inc., will continue to provide services to at-promise youth and youth involved in the juvenile justice system for one additional year, through December 31, 2024, at no additional cost. This contract extension request is to utilize unspent funds due to the impact of the COVID-19 pandemic had during the contract term. Staff recommend an extension as the best way to ensure resource stability and service continuity without potential disruptions of these essential services to at-promise youth and youth involved in the

juvenile justice system.
