



Success Story

One Door recently shared a success story of one their participants getting back on their feet. This participant completed their Sober Living Environment (SLE) program and obtained a part-time job. Upon completion of their SLE program, they were also able to obtain stable housing. In addition to their employment opportunity, the participant is currently registered in courses at California State University, Bakersfield to become a certified Drug and Alcohol Abuse counselor.

PPSA Agreements*

In September 2023, the CCP approved the use of funds to enter into Personal/Professional Services Agreements (PPSAs) in order to meet urgent needs. One agreement was to accommodate individuals with unique needs, and five were intended to resolve a lengthy waitlist. The agreements are in effect for one calendar year, with most expiring in November 2024. These agreements allow us to more quickly meet the needs of AB 109 participants and help them receive their housing services sooner.









Success Stories and a Look Ahead


One client was placed in the Multi-Craft Aprenticeship program, and two clients were placed in a paid Recycling Lives program. One client completed Truck Driver training and is working as a truck driver. 10 clients obtained unsubsidized employment including positions with Michael's, Daily Deals, Continental Labor, Key Staffing at The Garlic Company, JTS Modular, Con-Fab, Western Express (truck driving), San Joaquin Valley Dairy Equipment, and Painters Local #52. Wages range from \$16/hr to \$31.55/hr with four clients earning over \$20/hr. Ten clients were placed in Paid Work Experience (PWEX) with eight remaining active as of January. We have four active PWEX employer hosts (West Coast Biofuel, Habitat for Humanity Re-Store, Yellow Letters 'N Postcards, and Knight's Site Services), and are in the process of contracting with several more pending review by our contracted Employer of Record. We will be working with West Coast Biofuel to make a video highlighting opportunities there to be played in the housing units at Lerdo -- a great way to provide motivating information to inmates without disrupting detention staff duties.





The Kern County Veterans Service Department (KCVSD) has a dedicated Veterans Service Representative (VSR) designated to provide benefit advocacy and case management to veterans (and their families) at any stage in the criminal justice system. The initiative provides access to Department of Veterans Affairs (VA) benefits, California Department of Veterans Affairs benefits, as well as referrals to other community groups in an effort to eliminate barriers to successful reintegration into the community and reduce the recidivism rate of veteran offenders.

KCVSD has established a direct line of communication to incarcerated veterans via Kern Valley State Prison psychologists; this provides an opportunity to assist these incarcerated veterans by filing claims related to psychological trauma suffered during their time in service. Staff and inmates have the means of communicating through Zoom on tablets provided by the state prison. Future goals of KCVSD is to develop similar connections within other institutions throughout Kern County.

REPORT ON AB 109 CALIFORNIA PUBLIC SAFETY REALIGNMENT ACT OF 2011 PRIOR YEAR CARRYFORWARD RESERVES

Fiscal Impact: None

The County Administrative Office requests your Committee's receipt of the attached presentation to provide information on prior year AB 109 – California Public Safety Realignment Act of 2011 resources, available carryforward reserves, and recommendations for its use to enhance programming, security, and community safety while maintaining fiscally stable and sustainable practices.

In Fiscal Year (FY) 2019-20, your Committee elected to reduce the allocated AB 109 revenues in anticipation of a decline in sales receipts due to the COVID-19 pandemic. The State backfilled \$2,769,540 in FY 2020-21 and restored prior year base allocations in the amount of \$709,093.61. Furthermore, actual growth funds in FY 2020-21 and FY 2021-22 outpaced estimates by a combined \$1.3 billion statewide. Following the reconciliation of prior year funds, the County Administrative Office has identified a total of \$15,467,929.56 in carryforward reserves from budgetary savings, unanticipated growth, and carryover startup funds.

The County Administrative Office requests the guidance of the Community Corrections Partnership and the Executive Committee in the development of an allocation of prior-year carryforward reserves. Once approved by the Community Corrections Partnership, it will be included in the FY 2024-25 County budget, subject to approval by the Kern County Board of Supervisors.

Therefore, IT IS RECOMMENDED that your Committee receive and file this presentation.
