UPDATE

Staff from Probation, Behavior Health and Recovery Services, and Sheriff continue to work on a new Request for Proposal (RFP) for the Community-Based Organization (CBO) program. The timeline for the RFP remains in place at this time and is expected to be presented to the Board of Supervisors for approval on May 20, 2025, and released to the general public on May 21, 2025. The RFP Evaluation Committee has been established and will meet to evaluate submitted proposals throughout July and August 2025.

The new RFP term will be effective for three years, January 1, 2026 through December 31, 2028. The estimated amount for this new RFP is \$8.5 million. Below is the current RFP timeline:

SUBJECT: Request Amendment No. 3 to Agreement No. 682-2022 with One Door Community Resource

and Recovery Center

BACKGROUND

On December 13, 2022, the County of Kern entered into Agreement No. 682-2022 with One Door Community Resource and Recovery Center ("One Door") to provide case management services for male and female AB 109 participants effective January 1, 2023 through December 31, 2025, in an amount not to exceed \$300,000.

On March 18, 2025, the Kern County Probation Department received a notice from Fred Rowe, new Chief Executive Officer, notifying the County of changes in staffing and leadership that would alter the terms of the original Agreement No. 682-2022. This letter noted that previous executors Ronald "Louis" Wright and Jarris Wright are no longer employed by One Door, and that signing authority will now be under Dr. Frederic Rowe as he is the new Chief Executive Officer of One Door Community Resource and Recovery Center.
